
For the upcoming academic year, ICMR-DHR has graciously agreed to support a maximum of three (3) young faculty members from our esteemed University, preferably from clinical departments. This support includes a research grant of INR 50 lakhs for a total duration of five years or until the completion of the Ph.D., whichever comes earlier.

Furthermore, I wish to inform that DHR, ICMR Headquarters, New Delhi, via email dated 9th May 2024, has requested the submission of a list of up to six (6) faculties along with their respective filled and signed application forms in the prescribed format.

Therefore, all the interested young faculty members are requested to kindly send their application (to be submitted as a PDF document only) alongwith with prescribed proforma (format for application, concept note, and CV of prospective supervisor/co-supervisors are enclosed herewith) on the E-mail dean.medical@kgmcindia.edu latest by 23rd May 2024.

All the received applications will be scrutinized by the committee constituted by Hon'ble Vice Chancellor of this University. Following this, 12 faculty members selected by the above committee, all of whom will present their plan of work before the committee under the chairmanship of Hon'ble Vice Chancellor. The committee will then finalize the selection of six (6) faculty members to be forwarded to ICMR-DHR for consideration.
